**PARTICIPANTS OF MINORITY AGE**

**Medical:** It is the responsibility of the undersigned to insure that the above named person is medically fit to participate in strenuous on-rink or off-rink activities. As stated below, participation in hockey activities presents an inherent risk of injury to person or property. The undersigned certifies that the above named participant has no known conditions that prohibit or limit participation in any hockey/skating activities held at Desert Hockey Development (DHD) events. If in the future such a condition exists the undersigned must prohibit the above named participant from any hockey activities held at DHD events. Additionally, the undersigned must have primary medical insurance in place for the participant to cover any expenses related to any potential injury that may arise from their participation in any activity on premises. We do not cover medical claims.

Authorization to treat minor child in parent's absence: I, parent/guardian of the above named minor child, give permission to DHD or agent of, to act in my behalf when immediate medical or surgical care is needed.

**Conduct:** Spectators (patrons on premises as a result of your involvement in the activity) as well as participants must behave in a respectful manner to both person and property. Behavior which could potentially lead to bodily injury or injury to property will not be tolerated. Expressions of ethnic, religious or racial bias will not be tolerated. The undersigned acknowledges that they have read and fully understand the information contained in the 'Rules of Conduct' information sheet. Furthermore, they agree that they will be responsible in abiding by those rules and informing their spectators of the policies.

**Indemnification and Risk Acknowledgment:** In consideration of being allowed to participate now or in the future, in any manner in DHD related events and activities, the undersigned acknowledges, appreciates and agrees that:

1. The risk of injury from activities involved in this program is significant, including the potential for permanent paralysis and death, and while particular rules, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist; and,
2. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my participation; and
3. I willingly agree to comply with the stated and customary terms and conditions for participation. If however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately; and,
4. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS DESERT HOCKEY DEVELOPMENT, their officers, officials, agents, and/or employees, other participants, sponsoring agencies, sponsors and advertisers ("RELEASEES"), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE.
